3.2 Mixtures**Chemical characterization**

The product is an in vitro diagnostic colorimetric reagent containing picric acid (<17.5 mmol/L) and sodium hydroxide (>0.29 mol/L). It is based on the Jaffé reaction, in which creatinine reacts with picric acid in an alkaline medium to form a red-orange complex. The intensity of the color formed is proportional to the creatinine concentration in the sample. The selected measurement interval minimizes interference from other serum components.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
