3.2 Mixtures**Chemical characterization**

The product is an in vitro diagnostic enzymatic colorimetric reagent containing TRIS buffer (pH 7.8), L-aspartate, lactate dehydrogenase (LDH), malate dehydrogenase (MDH), NADH, and α -ketoglutarate. Aspartate aminotransferase (AST), formerly known as glutamate oxaloacetate transaminase (GOT), catalyzes the reversible transfer of an amino group from L-aspartate to α -ketoglutarate, forming glutamate and oxaloacetate. The oxaloacetate produced is reduced to malate by MDH in the presence of NADH. The rate of decrease in NADH concentration, measured photometrically, is proportional to the catalytic concentration of AST in the sample.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
