The product is an in vitro diagnostic enzymatic colorimetric reagent containing Tris buffer (pH 7.4), glucose oxidase ($\geq 10,000$ U/L), peroxidase (≥ 700 U/L), phenol (< 0.5 mmol/L), and 4-aminoantipyrine (≥ 1 mmol/L). It is based on the oxidation of glucose to gluconic acid and the subsequent reaction of the generated hydrogen peroxide with chromogenic substrates.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
