3.2 Mixtures**Chemical characterization**

The product is an in vitro diagnostic enzymatic colorimetric reagent containing dextran sulfate, magnesium chloride hexahydrate, Brij 35, PEG-modified cholesterol esterase and cholesterol oxidase, detergent, 4-aminoantipyrine (4-AAP), and peroxidase. After the addition of magnesium ions, dextran sulfate selectively forms water-soluble complexes with LDL, VLDL, and chylomicrons, which are resistant to PEG-modified enzymes. HDL-C in human serum is solubilized by a specific detergent and reacts with cholesterol esterase, cholesterol oxidase, and peroxidase to produce a colored compound. Non-HDL lipoproteins such as CM, LDL, and VLDL are inhibited by detergents and do not react with the enzymes. HDL cholesterol concentration is determined by measuring the color intensity following the Trinder reaction.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
