SECTION 3: Composition/information on ingredients**3.1 Substances**

3.2 Mixtures**Chemical characterization**

The product is an in vitro diagnostic enzymatic colorimetric reagent containing lipoprotein lipase (LPL), glycerol kinase, glycerol phosphate dehydrogenase (GPO), peroxidase (POD), 4-aminoantipyrine (4-AP), and p-chlorophenol. It is based on the enzymatic hydrolysis of triglycerides to glycerol and free fatty acids by LPL. Glycerol is phosphorylated by glycerol kinase and ATP to form glycerol-3-phosphate (G3P), which is then oxidized by GPO to dihydroxyacetone phosphate (DAP) and hydrogen peroxide (H₂O₂). In the final reaction, H₂O₂ reacts with 4-AP and p-chlorophenol in the presence of POD to form a red quinone dye. The intensity of the red color is proportional to the triglyceride concentration in the sample.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
