**3.2 Mixtures****Chemical characterization**

The product is an in vitro diagnostic enzymatic colorimetric reagent containing phosphate buffer (pH 7.4), uricase ( $\geq 60$  U/L), peroxidase ( $\geq 660$  U/L), ascorbate oxidase ( $\geq 200$  U/L), 4-aminoantipyrine ( $\geq 1$  mmol/L), and 2,4-dichlorophenol sulfonate (DCPS) (50 mmol/L). It is based on the oxidation of uric acid to allantoin and hydrogen peroxide by uricase,

followed by the reaction of hydrogen peroxide with chromogenic substrates (4-AP and DCPS) in the presence of peroxidase to form a red quinoneimine dye. The intensity of the red color is proportional to the uric acid concentration in the sample.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
