The product is an in vitro diagnostic latex agglutination test kit intended for the qualitative and semi-quantitative determination of Rheumatoid Factor (RF) antibodies in human serum.

The reagent contains polystyrene latex particles coated with human-derived IgG, suspended in buffered saline solution.

The kit also includes positive and negative control sera, test cards, and auxiliary accessories.

Positive and negative controls are derived from human serum and are non-reactive for HIV and HBsAg.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
