The product consists of in vitro diagnostic monoclonal antibody reagents used for the detection of A and/or B antigens on human red blood cells.

Anti-A, Anti-B, and Anti-A,B reagents are mixtures of IgM class monoclonal antibodies derived from mouse hybridoma cell culture supernatants.

The reagents are suspended in buffered saline solution and are ready to use.

Each production batch undergoes rigorous quality control for specificity, avidity, and performance.

Under normal conditions of use, the product is not classified as hazardous and does not contain any substances listed as dangerous under CLP Regulation (EC No 1272/2008).
